CONTEST NOTES: Our 25th year of contests begins and looking back at great times with many of you, but looking ahead to some more great times with all of you. This contest was great too, the weather and the conditions were good. The competitor had great attitudes and performances.

BOY'S DIVISION: It was a small turn out for this first contest, but those who show up did well. The finals was competitive as the contestants had to get some waves in late afternoon conditions. Coming out in first was **Jachin Hamborg** scoring 33.5 points, with a few 6's. In second with 25.5 was **Justin Davis** also riding some good waves. Taking third just behind with 24.5 was **Sam Wickwire** who had a great day, while **Brendan Hiruma** took fourth with 23 points, he had a great first CCSA contest with us. Fifth place with 22.5 was **Blake Bowie** and taking home sixth with 19.5 points was **Luke Barrett**. It was a good day, hope to see more of you next month.

Other results: Equal sevenths went to **Craig Bartlett** and **Riley Peterson** while equal ninths went to **Hunter Barrett** and **Nolan Rapoza**.

JUNIOR'S DIVISION: The final was solid and very entertaining. Scoring 34.5 and taking first was **Zach Porteous**, taking first and a third in his other heats. Taking second with 31 points was **Jake Caughill**, who had a few good rides in the final. Third went to **Luke Barrett** who scored 27 points, and also took sixth in the Boy's. **Nicholas Boyd** who scored first in the semis struggled in the final scored 25.5 and took fourth. **Jordan Deguin** earned fifth with 23 points, and surfing well throughout the day. Sixth, scoring 22 points was **Justin Davis**, who took second in the Boy's.

Other results: Equal sevenths went to **Tanner Chang** and **Jeremy Jennings** (who both had a firsts in other heats) while equal ninths went to **Bobby Ellis** and **Schuyler Zimmerman**.

MEN'S DIVISION: Very strong and very competitive, a great way to start the season. Scoring 37.5 in the final and perfect all

day was **Vance Smith**, scoring high in the final (who also took last years opening contest). Close behind was **Jachin Hamborg** and **Dan Fennell**, they both tied with 30.5, after the count back, Jachin took second closely on the count back (18 to 16) he also took first in Boy's. 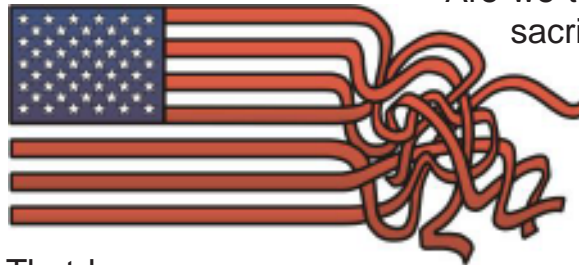
The Unpayable Debt We Owe

Stand fast therefore in the liberty by which Christ has made us free. —Galatians 5:1

Our gratitude is deepened when we remember the price others paid to help obtain freedom. In the United States, one such person was Richard Stockton.

Stockton was one of the signers of the Declaration of Independence. He was a prominent lawyer and a wealthy landowner. Because he supported the war efforts, he and his family were driven from their home. That home was sacked and burned. Stockton was imprisoned for several years and subjected to harsh treatment that broke his health. He died a pauper at the age of 51. Yet few Americans remember this hero who paid such a high price for the cause of liberty. His sacrifice is largely forgotten.

Even more important, have we become so familiar with the gospel that we fail to appreciate what our salvation cost the Savior? We rejoice in the



spiritual freedom we enjoy by faith in the sin-canceling death of Jesus, but do we realize at least to some small degree the price He paid?

Are we truly grateful to Jesus for all He sacrificed to set us free spiritually? If so, we are to "stand fast . . . in the liberty by which Christ has made us free" (Gal. 5:1). No matter what else may be demanding our attention, let's take time to remember the unpayable debt we owe Him. —
